Section 4 First Aid Measures

Emergency and First Aid Procedures

Inhalation: In case of accident by inhalation: remove casualty to fresh air and keep at rest.

Section 5 Firefighting Procedures

Extinguishing Media: Use alcohol resistant foam, carbon dioxide, dry chemical, or water spray when fighting fires. Water or foam may cause frothing if liquid is burning but it still may be a useful extinguishing agent if carefully applied to the fire. Do not direct a water stream directly into the hot burning liquid.

Section 6 Spill or Leak Procedures

Steps to Take in Case Material Is Released or Spilled:

Exposure to the spilled material may be irritating or harmful. Follow personal protective equipment recommendations found in Section 8 of this SDS. Additional precautions may be necessary based on special circumstances created by the spill including; the material spilled, the quantity of the spill, the area in which the spill occurred. Also consider the expertise of employees in the area responding to the spill. Avoid creating dusts. Cover material with absorbent and moisten and collect for disposal. Avoid contact with material. Avoid breathing material.

Prevent the spread of any spill to minimize harm to human health and the environment if safe to do so. Wear complete and proper personal protective equipment following the recommendation of Section 8 at a minimum. Dike with suitable absorbent material like granulated clay. Gather and store in a sealed container pending a waste disposal evaluation. Vacuum or sweep up material and place in a disposal container. Isolate hazard area. Keep unnecessary and unprotected personnel from entering. Do not allow the spilled product to enter public drainage system or open waterways.
