6. Accidental release measures

Personal precautions, protective equipment and emergency procedures: Keep unauthorized personnel away. Keep upwind. Ventilate closed spaces before entering them. Avoid inhalation of dust. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing.

Methods and material for containment and cleaning up:

Avoid dust formation. Sweep up and place in a clearly labeled container for chemical waste. Clean surface thoroughly to remove residual contamination.

Notification Procedures:

Dike for later disposal. Prevent entry into waterways, sewer, basements or confined areas. Stop the flow of material, if this is without risk. Inform authorities if large amounts are involved.

Environmental Precautions:

Prevent further leakage or spillage if safe to do so. Avoid discharge into drains, water courses or onto the ground.


